NOTE: THIS WOULD EXPLAIN WHY MARTI DELAYED THE 12-2-12 ELECTIONS AND CAUSED SO MUCH TROUBLE. (AP)

Mr. Harvey,

The board meeting tonight was canceled due to flooding that kept several board members from coming. Those of us who were there (the upcoming board leadership and several program directors), discussed the possibility of postponing the meeting until January. We rarely have had board meetings in December, and if the meeting is held in January, the new incoming board members will be elected and will be able to vote. This will assure that Jeff Lamb and his wife Debbie Thorpe will not be reelected, and will probably be voted off the board.

However, there is still the issue of the documents that Jeff has at his house. If you call the Philomath City Manager, or the Philomath Police Chief, they may be able to help return those documents to the office of PCS. This is important no matter who is president, and needs to be corrected at once. I know that there are copies of copies of some of the most important documents, like the 501c3 determination, but I don't think anyone has copies of all the minutes and that sort of stuff. Most of the financial records are still in the office, also, no one but Jeff and Debbie have a key to the cabinet where all these papers are kept.

Another concern that you could possibly address is to allow someone from PCS or even the city of Philomath to start collecting mail. As you know from our testimonies, Jeff does tamper with the mail. We often do not receive mail in a timely manner (so that at the food bank, we have to have documents for Linn Benton Food Share mailed directly to Dot Richardson's home address), and right now we are receiving replies to the recent fundraising letter, many of which will say "I will not donate until the current board executives resign" or something similar. Before Jeff was president, the treasurer always picked up the mail, since (s)he had to pay the bills and make the deposits. Jeff has forbidden that for the last several years. Could we set up a new PO box and have the mail forwarded to it? It could then be collected by Marti Staprans Barlow, who is a current board member and hopefully our next president, or even someone from the city manager's office (the City of Philomath is one of our biggest donors), until we have a new president.

I hope that you will hear from Marti Staprans Barlow, so that she can tell you directly the threats that Jeff made to convince her that she could be the new president only if she agreed to allow him to be president for 6 more months. He did threaten to cause problems for PCS (as if he hasn't done enough damage). Also, you will need to contact the woman who

prepared our taxes this year, Michelle Kellerman, about the audit. Marti said there was some sort of hold up.

If you can help in these ways -- documents, mail, and checking up on the audit status. I think
